Featured research: Accountability, Courts And Tribunals (ACT)

What should policy-makers do when it comes to the **nexus between migrant smuggling and human trafficking?** ACIL member **Dr. Jill Coster van Voorhout** (Assistant Professor of International and Transnational Criminal Law), led the presentation of the research findings and recommendations of the <u>T-STAN</u> project the at UvA on Thursday 11 January. T-STAN provides a new, evidence-based toolkit for Dutch, EU and UN policy-makers focusing on preventing and responding to 'mixed migration'. It takes a holistic approach to both crimes, migrant smuggling and human trafficking, on the route from Libya to the EU.

T-STAN is part of *Accountability, Courts And Tribunals* (ACT), which Jill established in The Hague in 2014. ACT is an interdisciplinary research program aimed at formulating research-based solutions for policy-makers and courts. It helps to counter challenges, such as gross human rights violations and international and transnational crimes, across two areas:

Fact-finding: Policy-makers and courts tend to emphasize the legal qualification of facts, rather than the process of finding those facts (fact-finding). This has had real-life consequences, including collapsed cases and miscarriages of justice.

Criminal justice: Policy-makers and courts face serious challenges regarding international and transnational crimes. New approaches, such as public-private partnerships and cross-learning between international and transnational crime regimes, are urgently required.
